The department performs portfolio-level planning, governance (including managing agreements, eligibility, project approval forms, etc.), forecasting/reporting, funding negotiations and related funding partner invoicing, asset management accounting, and other administration.

Job Overview

Reporting to the Senior Manager, Capital Finance, the Accountant, Asset Management is responsible for capital-related reporting and performs a key role in the full cycle asset accounting function. They assist the Senior Accountant, Asset Management with capital-related forecasting and in the development of funding models to meet debt-servicing needs. They support other departments by providing accounting guidance, analysis and information
