Department Summary

The Project Delivery Department of the Asset Management Division is responsible to plan and deliver capital projects that introduce new or upgrade existing infrastructure and fleet assets of the organisation. Project management resources are allocated to teams that provide centres of expertise for various asset classes. The team responsible for Low Carbon and On-Street Infrastructure constructs low carbon fleet energy distribution and dispensing infrastructure at existing facilities or on-route, and constructs transit exchanges and on-street transit priority infrastructure such as transit priority lanes and intersection features on roadway controlled by local governments.

The Facility Projects team constructs new operating and maintenance facilities that integrate bus charging or fuelling infrastructure and delivers upgrades to existing facilities.

Job Overview

Reporting to the Program Manager, Facility Projects or the Program Manager, Low Carbon and On-Street Infrastructure, the Project Manager, Capital Projects is responsible for managing the day-to-day operational and tactical aspects of multiple and multi-scaled construction or fixed asset infrastructure projects effectively, coordinating budget, scope, and scheduling to ensure adherence to timelines and project deliverables.

The Project Manager will collaborate closely with functional area sponsors as well as key internal and external subject matter experts, local government and operating partners, and vendors to ensure objectives are achieved. Our Project Managers support continuous improvement of project methodology.
